AnhThu called the meeting open at 6:07 p.m.

AnhThu stated “we received a request from Cecilia Carpenter to participate remotely in the February 18, 2026 DEI Commission meeting due to a personal matter that prevents her physical attendance at the meeting. I will now entertain a motion for her to participate.”

Mark moved to allow Cecilia to remotely participate in the February 18, 2026 DEI Commission meeting. The motion carried unanimously.

AnhThu asked Cecilia to state the location from which she was participating. Cecilia responded that she was in Staunton. AnhThu asked the commission and the audience if they could hear Cecilia. The response was affirmative.

60 **1. Approval of Minutes**

62 Jordan moved to approve the minutes of the January 21, 2026 DEI Commission meeting as
63 presented. The motion was seconded by Ian and carried unanimously.

65 Before moving on to Subcommittee report outs, AnhThu invited Anna Leavitt to introduce
66 herself. Anna explained her new role with the city and how she thought the DEI commission
67 could help gather lived experience and reach important parts of our community.

69 **2. Subcommittee Report Outs**

70

71 **a.** Community Connections – The commission is planning a “belonging event” for
72 November 2026 in partnership with Staunton City Schools. They have met with the
73 superintendent. Current priorities include securing a venue to display student
74 artwork. No follow-up meeting has been scheduled yet. Final messaging regarding
75 the Staunton DEI Commission conversation guide was sent to the commission for
76 feedback. No edits were suggested and the final version will be distributed to the
77 group. It defines DEI work within the specific landscape of Staunton and is
78 intended to serve as a standardized source for interviews and public conversations.
79 It was noted that the guide helped AnhThu focus her thoughts for the annual
80 presentation to Council. At their next meeting the subcommittee will discuss how
81 some of this might fit well on the city’s DEI webpage. Outreach to other city boards
82 and commissions is planned for March. The subcommittee is considering a mutual
83 aid event with a group like Project Grows, the Arrow Project, etc. There was
84 significant discussion regarding the term “mutual aid,” and there was a suggestion
85 to reframing the event as a “Community Support Fair” with a mutual aid
86 component. The event aims to provide immediate resources (example: food pantry,
87 clothing closet) alongside long-term support. The commission discussed tabling at
88 upcoming local events, including the SRHA Community Health and Wellness
89 Event on May 9 and the NAACP Mental Health Fair in July.

90 **b.** Data and Research – The subcommittee had positive meetings with City of
91 Staunton Human Resources and gave feedback to the city on its onboarding
92 materials. The commission is currently waiting for HR to complete its review of
93 the scaffolding and feedback given before moving to the next phase. There has been
94 some interest in more outward facing communication from this subcommittee.
95 There was discussion that this could be possible with help from the Community
96 Connections subcommittee.

3. Debrief – January City Council Update

The recent presentation received positive feedback, though some community members expressed disappointment at the long interval between updates. To increase transparency without increasing the workload, the commission discussed using the *Community Connections* newsletter for mid-year updates and directing interested members of the public to the DEI webpage and the meeting minutes. Members discussed the need for more intentional, small steps to build relationships with City Council, such as having a representative attend council meetings more regularly to view issues through a DEI lens.

Concerns were raised regarding ICE activity in neighboring Harrisonburg and Waynesboro. The commission discussed the lack of trust between undocumented residents and law enforcement. The Community Connections subcommittee discussed exploring the possibility of a community survey or listening session to gather feedback on safety and policing, which would then be reported back to the police chief.

AnhThu met with Daphne Cox, an advocate for the deaf community. A comprehensive plan update stakeholder meeting is scheduled for the evening of **March 4 at the Staunton Public Library**, and the DEI commission has been requested to attend.
